Overview

The Embassy of the United States of America in Botswana, Gaborone is soliciting services of CCTV surveillance installations. This Scope of Work (SOW) is to provide a complete design product. The process entails design, supply, installation, implementation, commissioning, training, providing user manuals, warranty on hardware's and software's, materials, services and support. All the necessary cabling/wiring and sockets will be specified in this SOW.

Bidder shall be responsible for the following scope of services and shall be their sole responsibility for the entire warranty period.

GENERAL

The contractor shall provide all materials necessary for the fully comprehensive work, unless otherwise specified.

The provision of skilled labor means Certified/trained laborers with at least three years' experience in their particular field, equipped with all hand/electrical tools, etc. necessary to carry out their work.

The contractor shall furnish the following documentation at time of bid.

- Quotation breakdown of work according to SOW
- Timeline for the project
- Certificates of skill sets for all foremen/supervisors
- Contact information for on-site supervisor and laborers
- Company Profile

The above documentation is mandatory at time of Bid. Otherwise, contractor will be deemed "Unacceptable".

Note: The US government will not provide mobilization fund on this project.

All quotes shall include installation, cleanup and repair of surrounding area, painting/spraying and surrounding area if necessary.

Damages: If carpets, tiles, or other items are damaged during the installation process, contractor shall be liable for repair or replacement. If any structures are damaged during the installation process, contractor shall be liable for repair or replacement.

Procedure: The work shall only be performed from Monday to Saturday.

Site Limitations: Please make arrangements with Residential Security Coordinator to have access to the residence at all times.

Performance Period: Project should be completed within 60 days from the time the purchase order is issued.

Site Conditions: The site will be free of any debris related to the construction services at the end of the project. Cutting or welding on the ground shall not leave any markings of any kind. To prevent marking the ground it is recommended that the cutting or welding be done offsite or have a protective layer for the pavers/ concrete. There shall not be any paint residue left at the workplace.

SCOPE OF WORK

1. Supply and install CCTV surveillance system of high-definition quality product.
 - a. 16 outdoor bullet cameras with a light catcher,
 - b. 2 indoor mini dome cameras with a light catcher
 - c. PC CCTV monitoring station,
 - d. 42'' CCTV viewing monitor
 - e. 32 Channel Network video recorder (NVR)
 - f. Supply and install a back-up UPS
2. The CCTV surveillance system shall be an IP network system
3. Connection cabling between the cameras and control station should be an outdoor ethernet Cat 6 cables, weatherproof/ fiber optic cable.
4. Note: There was an existing analogues system in place with cables containment and camera brackets. These brackets and existing routes will be used during installation. (to be detailed on-site)
5. Bidder must strictly adhere to the service level agreement during the warranty period.
6. The system should be provided with weatherproof IP Fixed camera, lens, housing & mounting.
7. The system must have the mobile software application for easy remote access.
8. Provide the warranty/on-site maintenance for the CCTV surveillance: Warranty of work:

(i) A court within the United States is able to exercise primary supervision over the administration of the trust; and

(ii) One or more United States persons have the authority to control all substantial decisions of the trust.

(b) Unless exempted, there is a 2 percent tax of the amount of a specified Federal procurement payment on any foreign person receiving such payment. See 26 U.S.C. 5000C and its implementing regulations at 26 CFR 1.5000C-1 through 1.5000C-7.

(c) Exemptions from withholding under this provision are described at 26 CFR 1.5000C-1(d)(5) through (7). (e) If the Offeror represents it is a foreign person in paragraph (d)(1) of this provision, then—

(1) The clause at FAR 52.229-12, Tax on Certain Foreign Procurements, will be included in any resulting contract; and

(2) The Offeror shall submit with its offer the IRS Form W-14. If the IRS Form W-14 is not submitted with the offer, exemptions will not be applied to any resulting contract and the Government will withhold a full 2 percent of each payment.

(f) If the Offeror selects “is” in paragraph (d)(1) and “partial or no exemption” in paragraph (d)(2) of this provision, the Offeror will be subject to withholding in accordance with the clause at FAR 52.229-12, Tax on Certain Foreign Procurements, in any resulting contract.

(g) A taxpayer may, for a fee, seek advice from the Internal Revenue Service (IRS) as to the proper tax treatment of a transaction. This is called a private letter ruling. Also, the IRS may publish a revenue ruling, which is an official interpretation by the IRS of the Internal Revenue Code, related statutes, tax treaties, and regulations. A revenue ruling is the conclusion of the IRS on how the law is applied to a specific set of facts. **For questions relating to the interpretation of the IRS regulations go to <https://www.irs.gov/help/tax-law-questions>.**
